

President's Report Euan Moore



The past year has been an extremely busy one for the VNPA. After years of fighting rear-guard campaigns to protect our natural environment, we

are now being consulted by government as a key stakeholder in environmental matters.

Our Executive Director, Matt Ruchel, has been heavily involved with the Forest Industry Taskforce, which is looking at ways to resolve the problem of protecting our old-growth forests in a way that will have widespread acceptance within the community. This work continued even while he was on long-service leave!

VNPA staff is increasingly engaging with government. This is stretching our capacity in the best way possible – we are working to have sound environmental management incorporated in proposals from the start rather than fighting threats already entrenched.

A major highlight for the year has been the two VicNature 2050 symposia that VNPA ran in association with The Royal Society, DELWP, Parks Victoria, Arthur Rylah Institute, Greening Australia and all Victorian Universities. The first of these brought together a range of top-level scientists who discussed the biodiversity impacts of climate change in their respective fields. The second concentrated on where and how we should intervene and whether such intervention, while hopefully protecting native species, will result in novel ecosystems different to those we have today.

Major grants during the year have enabled us to boost our NatureWatch capacity. Our Caught on Camera project has been extended to include Communities Listening for Nature, where audio recorders are placed in the forest to record and identify the sounds of the wild. Another grant has enabled us to reactivate our ReefWatch program.

Over the past few years staff and councillors have been working on our Strategic Plan. Now completed, it lays out the strategic goals for the VNPA in three themes: Conservation of Victorian nature and protection of natural heritage; Inspiring and encouraging all Victorians to experience, value and enjoy nature; and A strong independent and influential community-based organisation.

Our new system for managing our membership and supporter database is now fully bedded down and is an integral and reliable part of our operations. A new phone system has been installed to take advantage of NBN technology. Council has also approved the redevelopment of our website and online communications tools in line with the strategic plan. We should see the new-look website around the end of 2016.

All of this work can only take place because of the support that we get from our members and supporter base. I would like to thank every one of you for this support; it is what keeps VNPA running. Our income from donations and regular giving has continued to grow while our membership base has stabilised. If you are not already a regular giver, I would urge you to consider becoming one. We all want to see our organisation grow; you can help further by introducing new supporters to the VNPA.

I would like to thank our staff and volunteers who carry out so much work on your behalf. They are enthusiastic and dedicated and put in hours over and above the normal expectations.

Special thanks go to Chris Smyth, who served as acting director while Matt Ruchel was on long service leave. Chris, like Matt, kept everything running smoothly and was always on top of the issues of the day.

Finally, I extend my thanks to the Councillors who have assisted with the governance of the VNPA. There is a very wide range of valuable skills within our council and extends across all areas of our operations. It has been a pleasure working with you.

The Year in Review

Executive Director Matt Ruchel



It is always amazing to review the year past, when dayto-day priorities often deal with the urgent over the important. 2015-2016 has been characterised by some significant milestone achievements in

the first half and continued hard work on a range of strategic reforms in the second.

The Andrews Government moved on some of its key election commitments: the private development lease over the Point Nepean Quarantine Station was ended in July 2015 and the option of 99-year leases in national parks was removed from legislation in September 2015. This, we hope, puts to rest the push to privatise national parks.

The VNPA have been heavily involved in a raft of consultations with the government including on reviewing the native vegetation clearing rules, development of a new marine and coastal act, preparation of the state of the bay reporting, review of the Flora and Fauna Guarantee Act and the creation of a new state-wide biodiversity strategy. We also worked resolutely to improve funding for Parks Victoria, which has suffered drastic cuts over the past few years. Special thanks to Yasmin Kelsall who worked tirelessly to protect our unique habitats but left us during the year to pursue other interests.

During this past year, even while on long service leave, a large amount of my time has been involved in the Forest Industry Taskforce as one of four conservation representatives. The taskforce was established following an Andrews Government election commitment and comprises the major stakeholders of industry, unions and conservation groups. Its purpose is to reach common ground on a durable, long-term set of recommendations and proposals to government about the issues facing the industry: jobs protection, economic activity and protection of our unique native flora, fauna and threatened species, such as the Lead beater's Possum.

Thanks to your ongoing support, the VNPA's organisational capacity remains



stable and our community engagement and citizen science work is flourishing. NatureWatch is soon to celebrate its 10-year anniversary and has been strengthened with the new Communities Listening for Nature project in partnership with Museum Victoria. Also new to the VNPA is Kade Mills, the coordinator of a reactivated ReefWatch program. Caitlin Griffith has taken on the role of Manager Community Engagement and Learning to coordinate these expanded activities.

We welcomed back Chris Smyth, who not only filled the role of Acting Executive Director while I was on long service leave in 2015, but has variously applied his considerable skill to editing Park Watch, coordinating the development of our new website and campaigning on marine and coastal issues. Emily Clough, our Fundraising Manager, returned from parental leave, and our new Supporter Development Officer, Amelia Easdale, began in June. Maxine Hawkins left us during the year after more than six years of invaluable fundraising which, among other things, helped keep the lights on.

Last but not least, I wish to acknowledge Michael Howes and his long running editorship of Park Watch and other VNPA publications. Michael has taken the big step of retirement. His attention to detail and generosity of mind over many years - Park Watch December 2003 was the first he edited - will be sorely missed.

The work of the VNPA brings together a broad community of committed people and organisations that strive to secure and protect Victoria's natural areas. Financial donors, members, volunteers, partners, VNPA Council, committees and staff are all fundamental to our success. I thank and congratulate everyone involved in this amazing team effort during 2015-16 and we look forward to another successful year being part of nature in 2016-2017.

Bushwalking and **Activities Group**

The Bushwalking and Activities Group had a full program this year, providing a wide variety of opportunities to experience our natural environment. From snowshoeing at Mt Stirling to bird watching tours of Mud Islands in Port Phillip Bay, there were many activities on offer.

We had over 230 activities and social events listed, with an estimated 2,000 participants. These included day walks, Walk Talk & Gawks, base camps, easy going ambles, excursions by bus, overnight pack carry hikes, under 35s walks, family walks, meetup walks, bike rides, 4WD tours, bring a friend for free walks, canoeing, snorkeling, social nights, dinners and conservation events.

This is all thanks to our dedicated volunteers. We are proud to honour their contribution as walk leaders, emergency contacts, leader mentors, meetup coordinators, excursion organisers, event coordinators and committee members.

Our monthly Social Night speakers were engaging and informative, starting with Caitlin Griffith presenting the VNPA NatureWatch 'Caught on Camera' footage, followed by John and Ruth Stirling showing film of their trip to Japan, John Bales speaking about the trip to Canada, Campbell Phillips reporting on Australian wilderness heritage through the Wild Magazine, Sue Catterall speaking of the UK Coast to Coast walk, Zac Lewis of the Wildlife Conservancy giving a presentation 'Back from the Brink', and Deb Henry speaking of her Feathertop to Bogong hike.

BWAG hosts a number of training opportunities each year. Russell Bowey, our training leader, led two introductory briefings for new leaders. Rob Argent and Russell ran a two-day course on using GPS to assist navigation and the BWAG Committee held a leaders workshop to introduce BWAG online and meetup.

BWAGers participated in a broad range of conservation activities. These annual events are well supported by VNPA's loyal members. They are Project Hindmarsh tree planting in the Wimmera region, Grow West community planting day just west of

Melbourne, the malleefowl survey in the Wimmera, the Forests Forever Camp in East Gippsland, boneseeding at Arthurs Seat and the rabbit warren and weed survey at Hattah.

This year there have been a number of initiatives, the most noteworthy being the new format for the Activities Program. Thanks to the efforts of the VNPA staff, and in particular designer Mary Ferlin, we now publish an A4 quarterly as an insert of Park Watch, using attractive icons to depict activity types. In addition, the program can now be downloaded from the VNPA website.

Finally, a special thank you to the BWAG Committee members who make all this happen: Rob Argent, Russell Bowey, Gayle Davey, Deb Henry and David Moore. As Convenor, I am very grateful for their dedication.
